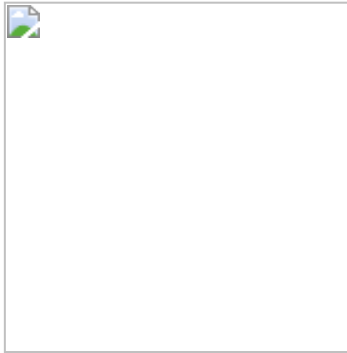

Gentlemen:

This refers to the news article entitled "SM Prime eyes Thailand, Malaysia, other ASEAN markets for expansion" posted in InterAksyon.com on June 24, 2015. The article reported in part that:

"MANILA - SM Prime Holdings Inc. plans to expand across Southeast Asian markets like Thailand and Malaysia to seize the opportunities offered by the forthcoming Association of Southeast Asian Nations (ASEAN) economic integration.

SM Prime chief financial officer John Ong announced plans to expand outside the Philippines and China during an investors' conference organized by the Bank of Philippine Islands (BPI).

'Apart from China, because there is certain affiliation in China, but we continue to accept, we continue to receive invitations in other ASEAN countries like Thailand and Malaysia. So we continue to entertain those opportunities and we look at synergy,' Ong said.

He said the company is looking to expand in the businesses the conglomerate is already engaged, particularly malls and residences.

'We continue to entertain those opportunities. We would definitely entertain (these) and we would be glad to go to other areas in ASEAN region,' he added.

Ong said the expansion plan is not yet factored in SM Prime's five-year roadmap to double its income to P32 billion by 2018.
